

**SUMMIT TRUCK EQUIPMENT
SEXY SERVICE TRUCK SHOWDOWN
SWEEPSTAKES RULES – U.S. & CANADA**

NO PURCHASE OR SUBSCRIPTION IS NECESSARY TO ENTER OR WIN.
A PURCHASE WILL NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility

"Sexiest Service Truck Showdown" (the "Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia and Canada (excluding Quebec) who have reached the age of majority in the participant's jurisdiction of residence at the time of entry. Employees, officers, directors of Summit Truck Equipment and other companies associated with the promotion of the sweepstake, and their respective parents, subsidiaries, affiliates, and advertising and promotion agencies, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. All federal, provincial, state, and local laws and regulations apply—Void in Quebec or where prohibited by law.

2. Sponsor

The Sweepstakes is sponsored by Summit Truck Equipment, located at 990 Vernon Rd, Wathena, Kansas 66090.

3. Agreement to Official Rules

Participation in the Sweepstakes constitutes the entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon compliance with these Official Rules and fulfilling all other requirements herein.

4. Sweepstakes Period

The Sweepstakes begins on March 3, 2026, at 8 am PST and ends on March 7, 2023, at 5 pm PST (the "Sweepstakes Period"). Entries submitted before or after the Sweepstakes Period will be disqualified. Submissions will be accepted for the duration of the Sweepstakes using the following method: Online Entry

5. How to Enter

Online Entry: This method of entry will be available by visiting our website (<https://summitbodies.com/summit-at-conexpo-2026/>) and following the directions provided to submit an official vote. Limit one (1) online entry per person. All online entries become the property of the Sponsor and will not be acknowledged or returned.

Bonus Entry (Facebook): Participants may receive one (1) additional entry by posting a photo of their favorite Summit service truck on Facebook during the CONEXPO-CON/AGG 2026 event. To qualify for the bonus entry, the Facebook post must: Include a photo taken at the Summit Truck Equipment booth during

CONEXPO-CON/AGG 2026, Tag @SummitBodies, and include the hashtag #SexiestServiceTruck Limit one (1) bonus entry per person. Posts must be publicly viewable to be eligible. The Sponsor is not responsible for posts that are not properly tagged or publicly visible.

6. Prize Drawing

On or about March 17, 2026, the Sponsor will select seven potential winners in random drawings from all eligible entries. One potential winner for each pool representing vehicles in the CONEXPO/CON-AGG booth space will be drawn. The odds of being selected depend on the number of entries received. Residents of Canada, in order to win, must first correctly answer a mathematical skill-testing question administered by email at the Sponsor's sole discretion. The Sponsor will attempt to notify the potential winners via telephone or email on or about March 17, 2026. Suppose the potential winners cannot be contacted within seven (7) days after the date of the first attempt to contact them. In that case, the Sponsor may select an alternate potential winner in their place at random from the remaining non-winning, eligible entries. No prize transfer or cash redemption. No prize substitution, in whole or in part, except by the Sponsor due to prize unavailability or any other reason solely determined by the Sponsor, in which case a prize of comparable or greater value will be awarded.

7. Winner Notification

The potential winners will be notified by email. Each potential Grand Prize winner (parent/legal guardian if a minor in their state of residence) will be required to complete, electronically sign, and submit a Declaration of Compliance within fourteen (14) days of the date notice or attempted notice is sent to claim their prize. If a potential winner cannot be contacted or fails to submit the Declaration of Compliance within the required period (if applicable), the potential winner forfeits the prize. Suppose the potential winner is at least 18 but still considered a minor in their jurisdiction of residence. In that case, the Sponsor reserves the right to award the prize in the name of their parent or legal guardian, who will be required to sign the Declaration of Compliance on the potential winner's behalf and fulfill any other requirements imposed on the winner set forth herein. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. If a potential winner is disqualified for any reason, the Sponsor will award the applicable prize to an alternate winner by drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded. Prizes will be fulfilled approximately 4-8 weeks after the conclusion of the Sweepstakes.

9. General Conditions

The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process, the operation of the Sweepstakes, or acting in violation of these Official Rules or unsportsmanlike manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision. All federal, provincial, state, and local taxes on the prize and all expenses related to acceptance and use of the prize, not otherwise specified, are the sole responsibility of the winner participating.
